Sub: Inviting recommendations for the Jamnalal
Bajaj International Award for Promoting
Gandhian Values Outside India.

I have the honour to write to you on behalf of the Jamnalal Bajaj Foundation, India.

The Foundation was established in the year 1977 in memory of late Mr. Jamnalal Bajaj, who was a close associate of Mahatma Gandhi who regarded Jamnalal as his 'fifth son'. The object of the Foundation is to serve the ideals for which Mr. Bajaj dedicated his life and to help promote the kind of constructive activities in which he himself was deeply involved during his life-time.

Since 1978 the Foundation has been granting 2 Awards to Institutions and Individuals in India in recognition of their meritorious work in the fields of social service and rural development. It added a 3rd Award in 1980, instituted in memory of Mr. Jamnalal's wife, Mrs. Jankidevi, which is given to women/institutions predominantly conducted by women, for their outstanding contribution for upliftment and welfare of women and children.

The Foundation has now decided to institute a Fourth Award for recognising outstanding work on Gandhian lines outside India, because it feels that the appeal of Gandhiji extends far beyond India. There is a large number of individuals, situated in all parts of the world, who have been inspired by Gandhi's philosophy and programme. Though all of them cannot be strictly called as Gandhian, yet they have been carrying out several constructive activities which aim at the achievement of the same values which Gandhiji held dear to his heart. And the spirit in which they are doing this work in their countries is the same in which Gandhiji worked for the people of India. The Foundation desires to duly recognise and honour such work of dedicated persons by conferment of this International Award. The Award will be given for the first time in 1985.

There is a Council of Advisers which guides the Foundation in operating its Scheme of Awards. Mr. Justice M. Hidayatullah, till recently the Vice-President of India, is the Chairman of the Council. Besides him there are several prominent persons from various walks of life who are members of the Council. For each Award the Foundation constitutes every year a Selection Committee for processing and evaluating the recommendations received. I am enclosing herewith a list of the members of the Selection Committee for the International Award.

I invite you to recommend a candidate for the Jamnalal Bajaj International Award for the year 1985. A few copies of the folder pertaining to the Award are enclosed herewith giving details such as : the objects of the Award, conditions of eligibility, form in which the recommendation is to be sent etc. I would particularly request you to support your recommendation with:

1. A curriculum vitae of the candidate;
2. A statement of the work and achievement on which the recommendation is based.

The last date for receiving recommendation is 31st May, 1985.

We are confident that your proposal will reflect the ideals and purpose which inform the institution of this Award, and will be of great value to the Foundation in arriving at its decision.

Mr. Javiar de Ecculler who is the Secretary General on U.N. sented all datas of lituretures and doccuments on the Africa Crisis through the Division of International Information on U.N. to I.C.W.A..
